Precept explained - it is a tax that we charge you to enable us to meet our budget requirements. Parish Councils do not receive any direct funding from central government, consequently we rely on the Precept plus the income from our land, cemetery & allotments to fund our expenditure. The Parish Council Precept is part of your Council Tax and is collected via your Council Tax payments, with the amount you pay being identified on the front of your account under Billingborough. The Precept requirement is the difference between our estimated income and our anticipated spending requirements for the financial year, ie. our budget. Our financial year runs from 1st April to 31st March. We must agree a budget before we can set our Precept and both must be agreed by the full Parish Council. When calculating the Precept, we take into consideration: • current year's spending levels - for ongoing services for which we are responsible e.g. recreation facilities, lighting, water, insurance, grass cutting costs, maintenance and staffing • costs of any additional spending plans or projects • provision for contingencies and reserves • levels of anticipated income – from land rental income, allotment contribution and cemetery fees. Currently there is no cap on the amount that Parish Councils can raise via their precept (District Councils and County Councils are capped). This is under consideration but for now Central Government expects Parish Councils to demonstrate restraint. We try to keep it ours as low as possible. When we have agreed the amount of Precept, we inform SKDC and it is then added to your Council Tax bill and SKDC pay us the Precept amount, which this year was £15,500.00. Part of the Precept Calculation is the 'Band D equivalent'. Band D is the middle band of Council Tax and is supposed to represent the amount of Council Tax paid on an average property in the area. The Band D equivalent provides a measure which allows precepts among councils of different sizes to be compared. The estimated number of Band D equivalent properties in the tax base is notified to the Parish Council by SKDC prior to our Precept setting exercise. The required Precept is divided by the number of houses in the tax base to get the Band D. This year ours equated to an increase of 2.8%, adding 0.85p to the Council tax bill of a Band D property.

No Mow May — the Council voted at their March meeting to support this by not cutting the Aveland field grass during May.

Our tennis courts are now open – and open access and free use continues. In return we ask that you respect the guidelines set out on the notices on the fencing, lower the net after use and report any inappropriate use to our clerk.

The waterfowl — are busy mating and having babies, which seems to make them behave recklessly and wander onto the roads surrounding the Spring Wells. So on their behalf we say — please be vigilant and slow down to give them and their young time to cross! Thank You!
